Non Resident Dues — \$750.00 Annually plus \$750.00 Food & Beverage Minimum

Spouse Privilege Dues — \$550.00 Annually plus \$550.00 Food & Beverage Minimum

Guides Dues — \$250.00 Annually plus \$250.00 Food & Beverage Minimum

Intermediate {21-35} Dues—\$375.00 Annually plus \$375.00 Food & Beverage Minimum

Corporate/Equity- Resident Dues— \$1900 No Food & Beverage Minimum

Corporate/Non Resident Dues— \$1900 No Food & Beverage Minimum

If the Food & Beverage minimum is not met upon renewal of your annual dues, the minimum left will be automatically charged to your account. Taxes and services Charges do count towards your Food & Beverage Minimums.
